### REPORT OF THE WORK OF RS FROM JULY 1991

The following, resolution proposed by PF, was passed at the CC on 16 July 1991.

" This CC recognises that there continues to be a break down in confidence of the majority of the CC regarding the activity of RS as national organiser.

In the light of continuing disruption caused by the dispute, the CC calls on the EC to take immediate steps to ensure the effective operation of the centre.

In particular the EC must appoint an additional EC member to help oversee the running of the org dept., pending the report of the commission.

The CC calls on cds RS and EG to cooperate fully with the EC and work under its direction."

THURSDAY 18 JULY The EC met ( RS and EG were informed of the meeting but were not present) FC was asked to work alongside RS. FC tried to convey the decision to RS by telephone several times but there was no answer.

FRIDAY 19 JULY RS was not at the centre again. FC tried to convey the decision several times by phone but there was no reply

SATURDAY 20 JULY FC tried to contact RS by phone, but still no reply.

MONDAY 22 JULY FC approached RS in the centre and told him of the decision. The agenda of the org committee was set jointly.

TUESDAY 23 JULY At the meeting of the org committee, reports were given by NW, RC, MW and FC on their respective fields of work. RS was asked to give account of his work but he refused.

FRIDAY 25 JULY At the EC meeting with RS present FC said that she was unhappy that RS was refusing to give any account of his work, particularly when he had been absent from important events.

WEDNESDAY 31 JULY At the org committee NW, RC and MW reported on their  
work. (FC was at the youth camp.) RS refused to give any account of his work.

THURSDAY 1 AUG RS had taken a holiday.

FRIDAY 2 AUG RS still on holiday

SATURDAY 3 AUG The EC received a note from RS informing them that he was in Scotland until further notice. RS was in Scotland carrying out factional activity.

MONDAY 5 AUG The EC met and reprimanded RS for his actions.

RS's first day back in the centre since Wednesday

31 JULY.

THURSDAY 22 AUG RS went on holiday

MONDAY 2 SEPT RS returned from holiday. He came in at 11am and left at lunchtime to attend the hospital with M.

THURSDAY 5 SEPT RS debated in LEEDS for the minority with FC.

FRIDAY 6 SEPT RS was off. He left a message at the switchboard that he was ill, but did not speak to any EC member. He attended the minority meeting in the evening.

SATURDAY 7 SEPT RS spoke at the national minority meeting in London

MONDAY 9 SEPT RS was off

10 - 12 SEPT RS attended the CC

FRIDAY 13 SEPT RS was off from lunchtime, taking baby to clinic. He attended the London minority meeting in the evening.

MONDAY 16 SEPT RS off because his baby was ill. He debated for the minority in Bristol.

TUESDAY 17 SEPT RS off because his baby was ill.

THURSDAY 19 SEPT RS debated for the minority in Liverpool.

FRIDAY 20 SEPT RS was off.

TUESDAY 24 SEPT RS off. He left a message on the switchboard that M was at hospital.

WEDNESDAY 25 SEPT RS off all day. He attended the poll tax courts which finished at 11am. The other comrades came in the centre, RS did not.

FRIDAY 27 SEPT RS left at lunchtime.

MONDAY 30 SEPT RS left a message at the switchboard saying his wife and baby were ill, but didn't speak to any EC member.

TUESDAY 1 OCT RS was off, but did not contact the centre.

WEDNESDAY 2 OCT RS was off, but no contact with the centre

THURSDAY 3 OCT RS still off, no contact.

FRIDAY 4 OCT RS still off, no contact.

MONDAY 7 OCT RS left a message at the switchboard saying he had flu, but did not speak to any EC member.

TUESDAY 8 OCT RS still off, presumably flu.

WEDNESDAY 9 OCT RS still off.

THURSDAY 10 OCT RS still off. RS travelled to Southampton to speak at a factional meeting in the evening.  
 FRIDAY 11 OCT RS still off, no EC member has been contacted.  
 MONDAY 14 OCT RS came into centre, left around lunchtime.  
 WEDNESDAY 16 OCT RS came into the centre at 10.45 am and left at 3.30pm.  
 THURSDAY 17 OCT RS was off without explanation  
 19-20 OCT At the British congress RS informed the EC he was taking a holiday from 23-25 October.  
 MONDAY 21 OCT RS was off without explanation.  
 TUESDAY 22 OCT RS was off without explanation. He attended a faction meeting in Newcastle.  
 WEDNESDAY 23 OCT RS was on holiday.  
 THURSDAY 24 OCT RS was on holiday.  
 FRIDAY 25 OCT RS was on holiday.  
 MONDAY 28 OCT RS was off, no explanation.  
 TUESDAY 29 OCT RS was off, no explanation.  
 WEDNESDAY 30 OCT RS was off, no explanation.  
 THURSDAY 31 OCT RS was off, no explanation.  
 FRIDAY 1 NOV RS was off, no explanation.  
 MONDAY 4 NOV RS was off, no explanation.  
 TUESDAY 5 NOV RS was off, no explanation. The EC agreed that KD should phone him and ask that he attend an EC meeting the next day and inform RS that he would be asked for an explanation of his conduct.  
 WEDNESDAY 6 NOV RS came in for the EC meeting and demanded to attend the forthcoming IEC. The EC voted against this. \*\*  
 FRIDAY 8 NOV RS phoned to say that he was at AW,s house holding a factional meeting to discuss the IS meeting.  
 SATURDAY 9 NOV RS attended the National Minority meeting in London.

\*\* The EC later reconsidered the decision to oppose RS attending the IEC at the request of the IS. However, this was done very reluctantly as RS had not been in the centre since the congress which was 3 weeks before. We were very reluctant to recommend he attend considering that he has carried out no general work for the tendency since JULY. He has solely been involved in factional activity for the last for and a half months.
